## **EXPERIENCE**

- Leading a team acting for a Hong Kong Listed "Red Chip" Company in relation to Securities and Futures Commission (SFC) and Commercial Crime Bureau (CCB) investigations on allegations of fraud and defalcation of trust. This case involved legal proceedings brought against the Commissioner for Police and Secretary for Justice concerning the scope of search warrants and issues of legal professional privilege, resulting in "break-through" case law developments relating to legal professional privilege in Hong Kong and limited waiver thereof.
